Tonight Becca gets to enjoy time with her parents. Becca is safe, warm, and feels closer to her family than ever before.*

Becca is exactly what you might expect from an 11 year old girl in the US: innocent and silly. She loves her friends and uses social media way too much.

Becca was quickly becoming close to one of her newer social media friends, a "14 year old girl" who seemed to understand everything that Becca was feeling. The new friends shared stories, emotions, and pictures of each other. Becca's new friend kept asking for more pictures, which were increasingly more revealing. It wasn't long before her new friend wanted to meet IRL (In Real Life).

In real life, Becca's new friend was a 32-year old male who preys on innocent children just like Becca.

Once aware of the danger, Becca's parents immediately contacted local authorities. With little evidence, the authorities could not step in yet; the parents went to the Internet looking for help and found the ILF.

At the parents' request, the ILF worked with the family and safely guided them. We turned the tables on the predator and provided Federal Law Enforcement with the information and evidence they needed to take action.

INNOCENT LIVES FOUNDATION VISION STATEMENT


To protect innocent children by unmasking predators who supply and trade in any child abuse material.

INNOCENT LIVES FOUNDATION MISSION

We unmask anonymous child predators to help bring them to justice.

When the ILF was formed, we started with two goals. First, to develop a robust mental wellness program, and second, to have a diverse and dynamic board of directors to help steer the organization. Only after those were in place could the ILF start to grow and accomplish its mission.

In June of 2017, after the ILF was formed, Chris spent time over the next year putting together that board of directors:

- Chris Hadnagy – CEO, Board Member and Professional Information Security Expert
- Timothy Maloney – Board Member and Legal Counsel
- Casie Hall – Board Member, Licensed Therapist, and owner of our Wellness Program
- Neil Fallon – Board Member and lead singer of the band Clutch
- AJ Cook – Board Member and Actress
- Robin Dreeke – Board Member and retired Director of the FBI's Behavioral Analysis Unit

As the ILF started to grow, the board developed a wellness program spearheaded by Casie Hall. Understanding that the InfoSec (Information Security) Community has unique skills and expertise to locate people anywhere they may attempt hide, Chris began assembling a team of highly-skilled security professionals to execute the ILF Mission.

With the growth came the addition of Shane McCombs as COO and together, this team leverages a formidable pool of talent and a diverse network of resources to “unmask anonymous child predators to help bring them to justice.”

We invite you to get to know us by sharing some of the ILF principles that guide our organization and decision-making processes.

FAILURE IS NOT AN OPTION

Predators count on roadblocks to break our spirit and make us abandon the hunt, but we will not relent! When a child's future – and possibly their life – is at stake we must fight. There is always another path to follow.

CHILDREN ARE OUR BENEFICIARIES

While we count on our contacts and love our donors, we exist to serve endangered children. When making decisions, policies, and planning for the future, the first question is, "How does this affect the children?"

EMOTIONAL HEALTH OF ILF TEAM

Our team is routinely exposed to soul-crushing subject matter. Before the ILF was granted official charitable status in 2017, a wellness plan was already in place and operational. We are actively evolving this plan to guard the emotional health of team members. Adherence is mandatory for all team members.

OPERATE ABOVE REPROACH

Our team of professionals operates under strict guidelines and regulations. There is no room or tolerance for errors or missteps. If we were to deviate from our procedures, a predator could go free.

NEVER EDUCATE A PREDATOR

Always ask, "If I publish this information, could I make a predator harder to catch?" Please know that there are many things we want to share with you, but we always ask ourselves whether it serves the best interest of the children to share the information. If it will arm the predators we opt to not give the information out.

We must adjust to changing times and still hold to unchanging principles.


